8. Consider calling for a public hearing in conjunction with the July 8, 2014 Regular Session to rezone 15 +/- acres of City property on Williamsboro Street from I-2 Special Use District to O-I Special Use District.

The City purchased this 15-acre tract as part of the Coon Creek Stormwater Improvement Project. There is still close to 6 acres available for development. The recommended rezoning request will add a buffer between the apartment complex and the Dill Air Controls property. There is 6 +/- acres available for possible development. (ATTACHMENT)

Recommended action: Staff and the Planning Board recommend calling for a public hearing in conjunction with the July 8, 2014 Regular Session to rezone 15 +/- acres of City property on Williamsboro Street from I-2 Special Use District to O-I Special Use District.

9. <u>Consider appointing Anthony Armento to the Historic Preservation Commission (HPC) for a 3-year term expiring June 2017.</u>

Mr. Armento's knowledge and experience with historic property would be an asset to the HPC. His application was the only one received for the open HPC Board appointment. (ATTACHMENT)

Recommended action: Staff recommends appointing Anthony Armento to the HPC for a 3-year term expiring June 2017.

10. Consider reappointing Vincent Gilreath to the Planning Board for a 6-year term expiring June 2020.

Mr. Gilreath was appointed in April to fill a vacant seat that expires this month. This is a reappointment of that seat on the Planning Board.

Recommended action: Staff recommends reappointing Vincent Gilreath to the Planning Board for a 6-year term expiring June 2020.

11. Consider reappointing Taylor Jackson and Howard Herring Jr. to the Fireman's Relief Fund for a 1-year term expiring June 2015.

The Fireman's Relief Fund consists of two appointees from the Volunteer Fire Department and two from the City Board. In addition, the City Finance Director is designated by the Insurance Commission and the Fire Chief attends in an ex-officio capacity.

Recommended action: Staff and Commissioner Currin recommend reappointing Taylor Jackson and Howard Herring Jr. to the Fireman's Relief Fund for a 1-year term expiring June 2015.

12. <u>Consider reappointing Jimmy Brummitt to the Vance-Granville- Henderson-Oxford Airport Authority for a 2-year term expiring July 2016.</u>

Mr. Brummitt has comprehensive knowledge of the Airport's needs, projects and goals. His reappointment would be an asset to the airport.

Recommended action: Staff recommends reappointing Jimmy Brummitt to the Airport Authority for a 2-year term expiring July 2016.

<u>CITY OF OXFORD</u> PUBLIC COMMENT GUIDELINES:

The Mayor and Board welcome and encourage citizens to attend City Board Meetings and to offer comments on matters of concern to them. Citizens are requested to review the following public comment guidelines prior to addressing the Board:

- a) Citizens are requested to limit their comments to five minutes. However, the Mayor, at his or her discretion, may limit comments to three minutes should there appear to be a large number of people wishing to address the Board.
- b) Comments should be presented in a civil manner and be non-personal in nature, fact-based, and issue oriented. Except for the public hearing comment period, citizens must speak for themselves during the public comment periods.
- c) Citizens may not yield their time to another person.

- d) Topics requiring further investigation will be referred to the appropriate City official, Board Committee or agency, and may, if in order, be scheduled for a future meeting Agenda.
- e) Individual personnel issues are confidential by law and will not be discussed. Complaints relative to specific individuals are to be directed to the City Manager.
- f) Comments involving matters related to an on-going police investigative matter and/or the court system will not be permitted.
- g) Citizens should not expect specific Board action, deliberation, and/or comment on subject matter brought up during the public comment section unless and until it has been scheduled as a business item on a future meeting Agenda.
