Public hearing for voluntary, contiguous, annexation of 2.455 acres of land located on Critcher Rd. (SR 1666) and NC Highway 158 Business owned by CKF Partners and VNSN LLC.

CKF Partners and VNSN LLC have petitioned the City to annex 2.455 acres of land located on Critcher Rd (SR 1666) and US HWY 158 Business consisting of parcels A, B, and C. CKF Partners owns parcel C and ½ parcel A. VNSN LLC owns parcel B and ½ parcel A. This property is in the Special Use District. A Special Use Permit was approved by the Zoning Board of Adjustment on September 9, 2013. The site was approved by the Property/Appearance committee on August 22, 2013. The property meets all requirements for contiguous annexation and all required procedures for voluntary annexation will be complete following the public hearing, and annexation can be approved. Consider water tap request for 6511 Highway 15 North.

Keith Adcock, property owner of 6511 Highway 15 North; has requested to tap onto the City waterline. There is no well on this property. City sewer service is not available; therefore, statutory requirements for annexation cannot be met.

Recommended action: Staff recommends approving the water tap for 6511 Highway 15 North.

10. <u>Consider amendment to the Oxford Code of Ordinances, Chapter 15, Article II Recreation Advisory Committee, to include staggered terms and change the frequency of the meetings.</u>

The staggered terms for the Recreation Advisory Committee need corrected and included in the Code of Ordinances. This Advisory Committee was originally developed with staggered terms, which are no longer present according to our current Organizational Directory. In October, the Committee will have 5 of 7 member terms expiring. Placing the staggered terms in the Ordinance will clarify when members cycle off and keep continuity to the Committee.

The ordinance also requires the Advisory Committee to meet monthly. Changing the required meetings to quarterly would be more practical for members and staff. The option to call additional meetings as needed, will remain in the ordinance. (ATTACHMENT)

Recommended action: Staff recommends amending the Oxford Code of Ordinance Chapter 15, Article II, 15-27 MEMBERS and 15-28 MEETINGS, to include staggered terms for Recreation Advisory Committee members and change the frequency of meetings from monthly to quarterly as presented.

The Mayor and Board welcome and encourage citizens to attend City Board Meetings and to offer comments on matters of concern to them. Citizens are requested to review the following public comment guidelines prior to addressing the Board:

- a) Citizens are requested to limit their comments to five minutes. However, the Mayor, at his or her discretion, may limit comments to three minutes should there appear to be a large number of people wishing to address the Board.
- b) Comments should be presented in a civil manner and be non-personal in nature, fact-based, and issue oriented. Except for the public hearing comment period, citizens must speak for themselves during the public comment periods.
- c) Citizens may not yield their time to another person.
- d) Topics requiring further investigation will be referred to the appropriate City official, Board Committee or agency, and may, if in order, be scheduled for a future meeting Agenda.
- e) Individual personnel issues are confidential by law and will not be discussed. Complaints relative to specific individuals are to be directed to the City Manager.
- f) Comments involving matters related to an on-going police investigative matter and/or the court system will not be permitted.
- g) Citizens should not expect specific Board action, deliberation, and/or comment on subject matter brought up during the public comment section unless and until it has been scheduled as a business item on a future meeting Agenda.
