#### LOCAL PREFERENCE BIDDING DISCUSSION

City Manager Hemann led a discussion on local preference bidding. The State allows a municipality to use a local vendor or contractor if their bid is within 5% of the lowest amount. The City Manager had asked staff to review current contracts and upon expiration, to advertise for bids. This had not been done in recent years. The outcome eliminated a local contractor who did not have the lowest bid.

The Board agreed to have City Manager Hemann write a policy that incorporates the local preference bidding option of 5%.
