- **21.** Save Thorndale Inc. is requesting to rezone 15.50 acres of property that is part of the previously named Thorndale County Club from R-A (Residential-Agriculture) and R-8 (1 & 2 family residential) to R-6 (1 & 2 family residential).

22. Save Thorndale Inc. is requesting to rezone 1.80 acres of property that is part of the previously named Thorndale County Club from R-A (Residential-Agriculture) to R-8 (1 & 2 family residential).
